Meet the Law School Administration

Associate Dean JOHN HENRY SCHLEGEL was acting dean for the fall 1983-84 semester while Law School Dean Headrick was on sabbatical. Schlegel has also been a full-time faculty member since 1973.

As associate dean, Schlegel is responsible for curriculum structuring, resolution of student academic problems and faculty assignments. Courses he has taught include Civil Procedure, Commercial Transactions, Judicial Decision-Making: The Second Circuit, Public Utility Rate Regulation, American Legal Education, and Sales and Secured Transactions.

Before joining the UB faculty, Schlegel was a Legal Aid attorney in Chicago and a teaching fellow at Stanford University's law school. He is a graduate of Northwestern University and the University of Chicago School of Law.

ALAN S. CARREL, associate dean for external affairs, in addition to his many responsibilities at the School, is the liaison between the Law School and its alumni. He directs the entire fund-raising program, works closely with the Alumni Association, oversees the operation of the Career Development Office, does a significant amount of academic and career counseling with students, is actively involved with the Admissions Committee and helps produce "The Forum."

Carrel attended Hamilton College and graduated from UB Law School in 1967. Prior to joining the staff, he was a partner in a Buffalo law firm, engaged primarily in litigation.
