to increase gifts received in the Annual Fund, according to Carrel. However, many significant projects must remain on hold, because the necessary funds are not available. "For that reason, we are currently planning a capital gifts campaign to begin within the year," said Carrel.

"It will focus on substantial, once-in-a-lifetime contributions that can have a significant, immediate impact."

Some funds may be designated for special projects, essential equipment, improvement of the facilities or new programs. Other large gifts may be set aside in endowment accounts and will be used to provide continuous support for teaching, research, the curriculum and educational student activities such as Moot Court. We also want to establish a Loan Repayment Program and to increase the number of scholarships that are available.

"The Law School's future depends heavily on the generosity of its alumni," he said.

"I am encouraged by the increase in support in recent years and am confident that we can obtain the funds necessary to meet the school's goals in the years ahead." ■
