- ADDICTION AND SOCIETY.** By Nils Bejerot. Springfield, Illinois: Charles C. Thomas, Publisher. 1970. xxii + 300 pages. \$9.75. Written for medical personnel, social workers, law enforcement officials, medical and social science students, and anyone interested in the problems of drug addiction, this book explores the nature of the present drug addiction spreading among the youth in many countries today.
- CIVIL LIBERTIES DOCKET.** Edited by Ann Fagan Ginger. Berkeley, California: Meiklejohn Civil Liberties Library. 1970. xxxii + 232 pages. \$15.00 (libraries and institutions, \$20.00). This volume describes many of the cases pending in state and federal courts throughout the country raising issues of civil liberties, due process, civil rights or the law of the poor.
- CREDIT REPORTING AND PRIVACY.** By John M. Sharp. Toronto, Ontario: Butterworth & Co., Ltd. 1970. xvi + 124 pages. \$6.95. This book explains the nature and workings of the agencies involved with credit reporting, as well as the main points of law which either protect or control them.
- DRUG ABUSE: DATA AND DEBATE.** Edited by Paul H. Blachy. Springfield, Illinois: Charles C. Thomas, Publisher. 1970. xvi + 322 pages. \$12.50. Taken from papers presented at the Second Annual Western Institute of Drug Problems held at Portland State University in August of 1969, these articles giving meaningful insight into the problems of drug dependence.
- FUNDAMENTALS OF CRIMINAL INVESTIGATION.** By Charles E. O'Hara. Springfield, Illinois: Charles C. Thomas, Publisher. 1970 (2d ed.). xvii + 854 pages. \$14.75. A completely revised version of the 1956 edition, this text focusing in on achieving operational effectiveness of investigative work.
- INTERNATIONAL CLAIMS: POSTWAR FRENCH PRACTICE.** By Burns H. Weston. Syracuse, New York: Syracuse University Press. 1971. xviii + 238 pages. \$10.75. This volume, the ninth in the *Procedural Aspects of International Law Series*, examines the French claims commissions established since World War II to distribute sums transferred to France by various countries as compensation for French property interests damaged, destroyed or otherwise affected by measures taken by such countries.

JUDGMENT ON NUREMBERG. By William J. Bosch. Chapel Hill, North Carolina: The University of North Carolina Press. 1970. viii + 272 pages. \$9.75. Subtitled "American Attitudes toward the Major German War-Crime Trials," this book evaluates the American public's reactions to those trials and draws conclusions upon: the legality of the tribunal, the composition of the court, the justice of the verdicts, and implications for the future.

JEROME FRANK: JURIST AND PHILOSOPHER. By J. Mitchell Rosenberg. New York, New York: Philosophical Library Inc. 1970. xviii + 274 pages. \$8.75. This is a study of the jurisprudential writings and judicial opinions of the late Judge Jerome Frank of the Second Circuit Court of Appeals.

LAW OFFICE ECONOMICS. Edited by the ABA Standing Committee on Economics of Law Practice. Chicago, Illinois: American Bar Association. 1970. viii + 264 pages. \$10.00. This book, composed of speeches delivered at the Fourth National Conference on Law Office Economics and Management, is divided into three parts covering 'What is Law Firm Management?'; 'Management Control Systems'; and 'Developing the Firm Financial Plan'.

LEGALLY AVAILABLE U.S. GOVERNMENT INFORMATION. Edited by Matthew J. Kerbec. Arlington, Virginia: Output Systems Corporation. 1970. 2 volumes. \$86.00. This work, written in two volumes, specifies what information is available from all federal agencies as a result of the Public Information Act of 1967 by explaining the provisions of the Act and describing agency policies and regulations governing the release of information.

MODERN TRANSPORTATION AND INTERNATIONAL CRIME. By Gordon Fraser. Springfield, Illinois: Charles C. Thomas, Publisher. 1970. viii + 108 pages. \$7.00. Directed primarily toward the student in crime detection, the author discusses many different types of international crime and how they are affected by modern transportation.

PROSECUTION: THE DECISION TO CHARGE A SUSPECT WITH A CRIME. By Frank W. Miller. Boston, Massachusetts: Little, Brown and Company. 1970. xviii + 366 pages. \$12.50. The prosecutor's responsibility and authority to charge a suspect with a crime, the criteria by which the determination to charge is made, and the degree to which the prosecutor controls what charges will be brought are studied in this book.

TAX PROBLEMS OF NON-PROFIT ORGANIZATIONS. Edited by George D. Webster and William J. Lehrfeld. New York, New York: The Journal of Taxation, Inc. 1970. 368 pages. \$15.00. From articles presented at the Sixth Annual American University Conference on Federal Tax Problems of Non-Profit Organizations, this book studies current problems of non-profit organizations and offers suggestions for solving them.

THE BARNYARD EPITHET AND OTHER OBSCENITIES. By J. Anthony Lukas. New York, New York: Harper & Row, Publishers. 1970. x + 110 pages. \$4.95. Subtitled "Notes on the Chicago Conspiracy Trial," Mr. Lukas describes the judge, the jury, the defendants and the prosecution involved with the Chicago Conspiracy Trial, in an effort to give the reader some insight into what really happened at the trial.

THE BASIC SYMBOLS OF THE AMERICAN POLITICAL TRADITION. By Willmore Kendall and George W. Carey. Baton Rouge, Louisiana: Louisiana State University Press. 1970. xii + 164 pages. \$6.00. Through an examination of documents universally recognized as requisites for understanding American political tradition, the authors explain the derailment of our political tradition and provide a sound basis for understanding tensions in the American system today.

THE NEW DRAFT LAW: A MANUAL FOR LAWYERS AND COUNSELORS. Edited by Ann Fagan Ginger. Berkeley, California: The National Lawyers Guild. 280 pages. \$10.00. Written as a reference for not only lawyers and draft counselors, but for registrants and draftees as well, this volume explains basic legal matters and draft procedures, and discusses and analyzes problems and misconceptions of the draft law.

THE POLITICAL PHILOSOPHY OF THE NEW DEAL. By Hubert H. Humphrey. Baton Rouge, Louisiana: Louisiana State University Press. 1970. xxiii + 128 pages. \$5.25. This study, the first publication of Mr. Humphrey's 1939 master's thesis, completed while a graduate student at Louisiana State University, analyzes the goals and methods of the New Deal and its relationship to democratic government.

THE POLICE AND THE UNDERPROTECTED CHILD. By C. J. Flammang. Springfield, Illinois: Charles C. Thomas, Publisher. 1970. xiv + 310 pages. \$11.75. A study of the role of police with respect to child protection, this book analyzes and compares the problems associated with child abuse and neglect.

THE POLICY MAKERS. By John C. Donovan. New York, New York: Pegasus. 1970. 256 pages. \$6.95. An analysis of how public policy is made at the national level in the United States, this book examines the influential role of technicians within the agencies of the institutionalized presidency, the rise of a military-congressional complex, the professionalization of social reform, the persistence of budgetary policies and the changing nature of the American policy.

THE SELF-INFLICTED WOUND. By Fred P. Graham. New York, New York: The Macmillan Company. 1970. xii + 378 pages. \$7.95. A book about the Supreme Court and crime in the United States, this work explores the Due Process revolution of the past decade through an analysis of landmark cases and their impact on public attitudes toward the Court.

THE SPIRIT OF AMERICAN PHILOSOPHY. Edited by Gerald Myers. New York, New York: G. P. Putnam's Sons. 1970. xii + 350 pages. \$6.95. Divided into six parts, this anthology of American philosophers traces the evolution of American philosophy from the seventeenth century to the present, covering such topics as: Religion, Government, Morality, Reason, Metaphysics, and Pluralism.

THE URBANIZATION OF THE EARTH. By Jorge Arango. Boston, Massachusetts: Beacon Press. 1970. xvi + 176 pages. \$6.95. Taking a broad view of existing conditions in cities and the causes of decay, this book traces the evolution of the city, with emphasis on the physical aspects of environment. The author offers a workable plan for the urbanization of the earth—an organic structure sensitive to human psychosocial needs as well as to technological advance.

VOICES OF THE NEW FEMINISM. Edited by Mary Lou Thompson. Boston, Massachusetts: Beacon Press. 1970. viii + 246 pages. \$5.95. Covering such topics as: History, Ideology, Problems and Goals, Emerging Life Styles, and Program for The Future, this book presents a number of views from leading advocates of the women's rights movement.

WORLD DIALOGUE ON ALCOHOL AND DRUG DEPENDENCE. Edited by Elizabeth D. Whitney. Boston, Massachusetts: Beacon Press. 1970. xiv + 400 pages. \$12.50. Designed to bridge the information gap between experts, interested professionals and laymen, this work presents a series of essays reflecting current thinking and investigation with respect to the problems of alcoholism and drug dependence.
